Gift Annuity Rates

Gift annuity rates range from 5.0% at age 60 to 9.5% at age 90 or over. The rate depends on your age at the time the agreement is entered and whether there are one or two gift annuitants.

For those who are ages 45–60, a gift annuity that delays payment to some future date can provide a higher rate and be a helpful source of supplemental payments at retirement.

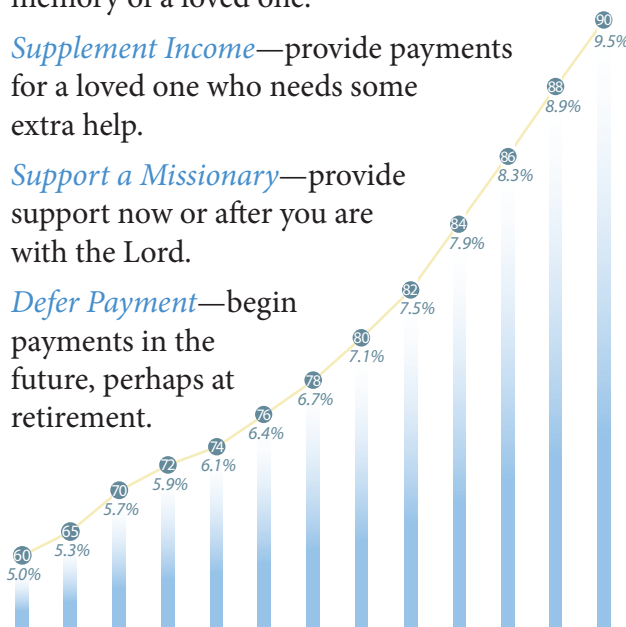

Appreciated Property Gifts

Using appreciated stocks, bonds, mutual funds or other securities can provide significant tax benefits. Some of the taxable capital gains are avoided, and any reportable gain can be spread over the life of the annuitant-donor. This greatly reduces the tax impact and provides payment to you based on the full value of the appreciated asset.

Deferred Payment Options

The *deferred payment* gift annuity may be more attractive for those between the ages of 45–60. If you'd like to learn more, give us a call and we can tell you how this would work for your specific situation.

The *flexible payment* gift annuity allows you greater freedom in determining when future payments are to begin. This option allows you to select a target date for payments to start. Then, as that date approaches, you can allow payments to start as scheduled or further delay the starting date for one or more years. Each further delay increases the payout rate you receive.
